**Mieko Nakabayashi** who served as a Member of Japan's House of Representatives from 2009 to 2012 (elected from the 1st District, Yokohama, Kanagawa Prefecture), is currently an associate professor at Waseda University, Tokyo, as well as the university's Associate Director for Global Leadership Program. She is in charge of core courses for the university-wide Global Leadership Studies minor offered by the Center for International Education. During her tenure at the House of Representatives, Nakabayashi served as Director of the Foreign Affairs Committee, the Financial Affairs Committee, and the Special Committee on Anti-Piracy Measures, Prevention of International Terrorism, and Japan's Cooperation and Support. She also served as a member of the Budget Committee, the Governmental Affairs Committee, and the National Security Committee.

As a member of the then-ruling Democratic Party of Japan (DPJ), Nakabayashi served as the Vice Director-General of the International Department, as well as the Assistant Director-General of the party.



**Audrey Boone Tillman** is executive vice president and general counsel at Aflac Incorporated. She directs Aflac's legal division and functions related to Corporate Communications, Compliance, Government Relations, Federal Relations, Global Cyber Security, and the office of the Corporate Secretary. In addition to her role at Aflac U.S., Tillman's responsibilities also include oversight functions of the General Counsel and Compliance offices at Aflac Japan, where the company earns more than 70 percent of its revenues.

Prior to joining Aflac, Tillman served as an associate professor at North Carolina Central University School of Law. From 1990 to 1993, she was an associate with the Smith, Helms, Mulliss and Moore law firm in Greensboro, N.C., and also served as a federal judicial law clerk to Judge Richard C. Erwin, U.S. District Court for the Middle District of North Carolina. Ms. Tillman is a member of the executive committee of the Corporate Counsel Section of the Georgia State Bar and serves as a tri-chair on the Columbus, Georgia Chamber of Commerce Regional Prosperity Initiative. She is a member of the State Bars of Georgia, North Carolina and the District of Columbia and is a past chair of the corporate law section.
